## Dear Distinguished Colleagues!



Following Matjaž Geršič's presentation, I would also like to take this opportunity in the newsletter to introduce myself to all of you as the new Co-chair of the Joint ICA/IGU Commission on Toponymy, on behalf of the International Geographical Union. As a first step, I believe it is necessary to thank my predecessor, Cosimo Palagiano, for the excellent work carried out during their term and for the promising prospects they have opened up for the future. I would also like to express my gratitude to those who have entrusted me with this role. Finally, I would like to thank Matjaž Geršič for providing this space for my introduction;

I am excited to begin this new journey together.

A few words about myself: I am a historical geographer and a professor at the University of Trento (Italy). I believe that Trentino, historically a border area between different worlds and cultural areas, with a long history of toponymic layering, is a perfect example of the complexity, but also the fascination, of studying place names.

The themes, approaches, and research interests involved in the study of toponymy are numerous, just as there are many different perspectives that animate this commission. In particular, I hope that in the future, some strategic research avenues may open up, such as the one that connects toponymy and migrations, or the study, recovery, and enhancement of historical toponymy, which serves both as a source for studying the relationship between society and space and as intangible cultural heritage in its own right.

In conclusion, I can only welcome Matjaž's invitations for closer integration and fruitful scientific exchange within our community. For this reason, I hope there will be many opportunities to meet in person, in the form of conferences, seminars, and panels, and I will personally commit to organizing some of these, in the hope of meeting and greeting you all.

# Workshop "Naming the Community: Identity Reconfiguration in Central and Eastern Europe"

Prague, Czechia, 16-17 May 2024

The aim of this workshop was to bring together researchers working on the politics of toponymy in Central and Eastern Europe to look for similarities and differences in the development of national and regional (re)naming ideologies and practises. What role did place names play in the transformation of Central and Eastern European identities? How did they support or hinder the transformation processes? How democratic were the changes to place names and who was included or excluded from the process? What role do official and unofficial names play in public and private discourse in the process of identity formation and memory reproduction? And what role will place names play in the region in the near future?

The two-day workshop was a friendly meeting of like-minded researchers with the aim of building a professional network for future collaboration on joint research projects and joint publications.

## The 10th Arab Forum for the Geographic Names

Jeddah, Saudi Arabia, 10-12 November 2024

Experts from 22 Arab nations and international organizations gathered for the start of the 10th Forum of the Arab Division of Experts in Geographical Names, which is scheduled to run for three days.

The event is being held under the theme "Strengthening Relations and Links Between Arab States in the Field of Geographical Names," and is hosted under the auspices of Prince Khalid bin Salman, the minister of defense and chairman of the board of directors of the General Authority for Survey and Geospatial Information.

The conference, which was opened by Jeddah Gov. Prince Saud bin Abdullah bin

Jalawi, aims to facilitate joint Arab action in various fields, including the documentation of geographical names; unifying geographical names in Arabic, avoiding the use of colloquial dialects; and launching new national committees.

Mohammed bin Yahya Al-Sayel, president of the authority, noted that Saudi Arabia placed great importance on the topic of geographical names.

The authority on the opening day signed 10 memorandums of cooperation with a number of entities in the government sector, the academic sector, and the nonprofit sector.

Tim Trainer (ICA), a part-time consultant to the UN and former chief geospatial scientist for the US Census Bureau, told Arab News: "The collaboration, from a regional perspective, is very impressive, and it seems there is a positive path to that collaboration."

#### Public place naming: Towards a gender inclusive cityscape

This policy brief is proposed by the UNESCO Chair in Inclusive Toponymy from the University of Geneva. It is devoted to promote a gender-balanced public space through place names.


It is aimed at all stakeholders involved or wishing to become involved in place naming and its social enhancement, in particular local authorities, their elected representatives and administrations, neighborhood and heritage associations, feminist activist groups and educational institutions.

It was drawn up following a multi-stakeholder forum and is based on a critical analysis. of a number of remarkable and/or inspiring experiences. In particular, Geneva's proactive experience is a point of reference and the City of Geneva is partner in the project. The recommendations and examples are divided into four stages, each representing a potential area for action:

- · Mapping the issue
- Identify eligible female personalities for naming
- · Inventing places to name
- Naming qualitatively

In this way, all the actors involved can participate with inspiration and creativity in an approach to renovating and opening up public space that combines functionality, inclusion, participation and an understanding of the social and historical aspects of places.


